# ROCKLAND COUNTY RENT GUIDELINES BOARD NOTICE OF PUBLIC HEARINGS AND MEETINGS

IN RESPONSE TO THE GOVERNOR'S DIRECTIVE TO TAKE EVERY EFFORT TO KEEP NEW YORKERS SAFE AND MITIGATE THE SPREAD OF COVID-19, AND PURSUANT TO EXECUTIVE ORDER 202-1 AND ITS UPDATES, THE ROCKLAND COUNTY RENT GUIDELINES BOARD ("RRGB") WILL BE CONDUCTING A PUBLIC MEETING TO, AMONG OTHER THINGS, SCHEDULE DATES FOR PUBLIC HEARINGS AND MEETINGS TO DETERMINE THE GUIDELINE RATES OF RENT ADJUSTMENT FOR HOUSING ACCOMMODATIONS WITHIN ITS JURISDICTION, SUBJECT TO THE EMERGENCY TENANT PROTECTION ACT OF 1974 ("ETPA") FOR LEASES COMMENCING BETWEEN OCTOBER 1, 2021 AND SEPTEMBER 30, 2022 VIA TELECONFERENCE. To hear testimony from tenants and owners concerning how the Board should determine the rent adjustments, if any, for leases of apartments subject to the Emergency Tenant Protection Act of 1974, as amended, and which commence on or between October 1, 2021 and September 30, 2022 and for such other business that may come before the Board.

On the date of the meeting, all persons who have signed up to speak will be provided with instructions on how to call in to the meeting and will be required to call in when prompted by the Chair.
