These proposed amendments reflect modification of various substantive and procedural provisions with respect to such matters including but not limited to: deregulation, overcharges, substantial rehabilitation, demolition, succession rights, individual apartment improvements, and major capital improvement provisions based on The Housing Stability and Tenant Protection Act of 2019, Ch.36 of the Laws of 2019 ("HSTPA"), and Ch. 39 of the Laws of 2019 and DHCR's own experience in administration, and court cases decided since the last major set of amendments to these rules in 2014.

Pre-registration of speakers is advised. Pre-registered speakers who have reserved a time to speak will be heard at approximately that time. Speakers who register the day of the hearing will be heard in the order of registration at those times not already reserved by pre-registered speakers. Speaking time will be limited to five minutes in order to give as many people as possible the opportunity to be heard. Speakers should be prepared to submit copes of their remarks to the DHCR official presiding over the hearing. The hearing will conclude when all registered speakers in attendance at the hearing have been heard.
