

New York State Preservation Program

Established in 1977 and 1980, respectively, under Articles XVI and XVII of the Private Housing Finance Law (PHFL), New York State Homes and Community Renewal (HCR) administers the Neighborhood and Rural Preservation Program. The Neighborhood and Rural Preservation Program (N/RPP) promote and preserve housing for low- and moderate-income individuals by providing administrative funds to community-based not-for-profit corporations known as Neighborhood and Rural Preservation Companies (NPCs and RPCs).

The enactment of Article XVI creating the Neighborhood Preservation Program (NPP) was based on the legislative finding that community development organizations rely heavily on voluntary services, short-range funding, and are typically underfinanced and understaffed. These challenges made it difficult to dedicate time to long-range planning and sustainable solutions for housing preservation and community renewal in a neighborhood. Section 902 of Article XVI authorizes Preservation Companies to engage in a wide range of planning and administrative activities designed to preserve and promote housing opportunities for low- and moderate-income persons in the neighborhood or community they serve.

The Rural Preservation Program (RPP) was established by Article XVII to support community-based not-for-profit corporations in rural preservation activities. Modeled after the NPP, Article XVII differs in that it recognizes the unique needs of rural areas of the state. Section 1002 of Article XVII authorizes rural preservation companies to engage in a wide range of planning and administrative activities designed to protect and promote housing opportunities for low-and moderate-income persons in the rural areas they serve.

Included in this Annual Report are summaries of activities completed by the Neighborhood and Rural Preservation Companies under contract with HCR during state Fiscal Year (FY) 2017-18.

PRESERVATION ACTIVITIES

NPCs and RPCs use the seed money provided by the N/RPP to provide consistent services throughout the program service areas. Activities performed by Neighborhood and Rural Preservation Companies include housing rehabilitation and development, tenant and homeowner assistance, housing management, first-time homebuyer counseling; foreclosure counseling; and community development and preservation. Preservation Companies also write and administer grants and participate in local planning efforts.

In FY 2017-18, Preservation Companies identified the following accomplishments in the N/RPP annual performance reports:


- ♦ 13,249 home improvement and rehabilitation projects either in progress or completed;
- 2,611 new residential units in progress or completed;
- 681 non-residential construction projects in progress or completed.

LEVERAGING PROGRAMS

New York's network of NPCs and RPCs are important vehicles for delivering the services of the "Local Programs" awarded through New York State Homes & Community Renewal's Office of Community Renewal. NPCs and RPCs have become adept at strategically delivering these programs and leveraging additional resources to bolster their communities. Specifically, NPCs and RPCs were awarded:

- ♦ 60% of Affordable Housing Corporation awards \$23.1 million
- ♦ 53% of NYS HOME Local Program awards \$6.5 millions
- ♦ 5% of New York Main Street development awards \$349,500
- ♦ 76% of HUD Housing Counseling awards \$478,853.00
- ♦ 68% of Project Reinvest: Financial Capability awards \$214,020

TECHNICAL ASSISTANCE

In the 2017-2018 Program Year, HCR provided training opportunities and technical assistance under the Housing Trust Fund Corporation (HTFC), along with its partners the Neighborhood Preservation Coalition of New York State, Inc. and the New York State Rural Housing Coalition, Inc. (collectively known as "the Coalitions"), including webinars and one-on-one preservation company assistance.

The Coalitions provide direct technical assistance to NPCs and RPCs via workshops for companies, as well as training at the respective annual conferences. Preservation Program Staff works in concert with the Coalitions to provide multi-pronged support to an extensive network of NPCs / RPCs.

FUNDS GENERATED UNDER PRESERVATION CONTRACTS

Article XVI of the Private Housing Finance Law requires that at least one dollar in match be generated for every three dollars of preservation funds received. The required program match for 2017-18 was one-half the awarded amount. Match funds are additional funds reported by the N/RPCs as received and expended during the contract period to defray administrative costs or capital projects. N/RPCs are encouraged to apply for grants and fundraise to meet the N/RPP match requirements.

Neighborhood Preservation Company Funding

HISTORY AND HIGHLIGHTS

The NPP was established in 1977 with 50 companies receiving grants of \$10,000 each. In the 41 years that the program has been operating, the Governor and Legislature have appropriated more than \$410 million to help Neighborhood Preservation Companies to achieve their community preservation and revitalization goals. In FY 2017-18 there were 143 NPCs in the program.

Statistics included in this report illustrate mandatory matching funds generated from federal, state, local, and private sources, as well as in-kind services that NPCs provided in their annual reports. In FY 2017-18, \$13.3 million was appropriated to the Neighborhood Preservation Program. Each NPC received an award of \$93,669 for FY 2017-18. These funds helped NPCs raise \$449,314,416 in match and leveraged funds. For every preservation program dollar appropriated, the NPCs raised \$33 for their communities. The following are highlights compiled from NPCs Annual Performance Reports in the last completed contract period of FY 2017-18:

- \$134.3 million in administrative and capital match funds of which, approximately \$85 million was raised from individuals, municipalities or other not-for profit entities;
- \$315 million in leveraged funds, of which approximately \$234.5 million was raised from individuals, municipalities or other not-for profit entities;
- Capital improvements to 109 non-residential units and new construction of 510 non-residential units.

NEIGHBORHOOD PRESERVATION PROGRAMS ACTIVITIES

The tables below detail the preservation activities reported by the 143 NPCs during the 2017-2018 Program Year. Please note that most NPCs engage in multiple housing preservation / community development activities.

Summary of

Rural Preservation Company Funding

HISTORY AND HIGHLIGHTS

The Rural Preservation Program (RPP) was established in 1980 with 14 companies receiving grants. In the 38 years that the RPP has been in place, the Governor and Legislature have appropriated over \$165 million to provide funds to RPCs. As of FY 2017-18, the number of RPCs has grown to 59.

Statistics included in this report illustrates the mandatory matching funds generated from federal, state, local, and private sources, as well as in-kind services that RPCs reported in their annual reports. In FY 2017-18, \$5,504,524 in preservation program funds helped RPCs raise \$134,045,060 in match and leveraged funds. Of the total program appropriation of \$5.5 million, each RPC received an \$93,297 for FY 2017-18. For every preservation program dollar appropriated, the RPCs raised \$24 for their communities. The following are some highlights from the last completed contract period of FY 2017-18:

- RPCs listed approximately \$63.5 million in administrative and capital match funds, of which \$9.5 million was raised from individuals, municipalities, or other not-for-profits
- RPCs listed approximately \$70.5 million in leveraged funds, of which approximately \$12.3 million was raised from individuals, municipalities, or other not-for-profits
- RPCs listed capital improvements to 62 non-residential units
