SENIOR PARALEGAL

DUTIES:

The senior paralegal will be responsible, for assisting attorneys in the legal department with respect to real estate and bond transactions financed by HFA, as well as broad HCR administrative matters. The position requires: (a) legal research and writing assignments; (b) attending mortgage closings and assisting in-house attorneys with all matters relating to such closings, both in advance of and in connection with the actual closing; (c) preparing mortgage closing transcripts; (d) drafting board memorandum/resolutions; (e) tracking legislation, and any other tasks deemed necessary by the Counsel or Deputy Counsel. The senior paralegal will also perform legal research for attorneys and assist attorneys in providing routine legal services related to the Agency's loan management and mortgage enforcement efforts for housing projects.

QUALIFICATIONS:

- Must be well trained in paralegal practices with at least five (5) years of law office experience, and supervisory skills.
- Must be self-motivated and able to take on responsibilities with minimal supervision.
- Ability to establish effective working relationships with staff and attorneys and outside contacts.
