OHP monitors over 200,000 low income housing units financed with federal and state resources, and provide grant funding to help homeowners and tenants save energy.

The Financial Operations Unit is responsible for the financial monitoring of the Agency's existing housing loan portfolio. This portfolio has been financed through conventional and public financing programs including the Agency's secured loan rental program, subsidy loan program, and the Mobile Home Cooperative Program.
