MWBE/SDVOB Goal Setting Software Solicitation**

1. What is the current system HCR is using?

HCR is currently Using Axi Systems. (November 1, 2021)

2. Is this bid a renewal or rebid?

This is a new solicitation process requesting a new bid. (November 3, 2021)

3. Is HCR considering SBE vendors or a combination of SBE/M/WBE?

HCR is considering Small Businesses and NYS-Certified M/WBEs. (November 3, 2021)

4. What are some of the challenges with the current system that should be considered in the next proposal?

Proposers should consider the minimum requirements that are outlined in the solicitation. (November 3, 2021)

5. Is there supposed to be a Tab 9? If so, what would it be?

Renumber Tab 10 to Tab 9 as follows:

~~Tab 10~~ Tab 9. All proposers, domestic and foreign, must be in compliance with New York State business registration requirements. Contact the NYS Department of State regarding compliance. (November 9, 2021)

6. How many users would need to access?

Our user needs will vary. Please indicate the maximum number of users that comes with your solution. You should consider including the cost of each additional user in your proposal. (November 15, 2021)

7. How many administrators would you like to have?
The number of desired administrators will depend on the solution. (November 15, 2021)

8. Does the software need to be compatible with any specific software or hardware? (For example: compatible with mobile devices, Apple, Microsoft or Android)

Your solution must be web-based and compatible with Windows 10, Windows 11, and commonly used Internet browsers including Internet Explorer and Chrome. (November 15, 2021)

9. Was there a scope document created by your technical team to make sure that our software meets your needs?

All pertinent information regarding the scope of services is included in the solicitation document. (November 15, 2021)

10. Are you looking for OKR (objective and key results) software?

11. Are you currently using a goal setting software and are there key features that you want to maintain and key features you feel are absent?

The solution should be fully implemented within 30 days of contract award. (November 15, 2021)

16. Is the document management system intended to be general purpose or is it application specific?

This will depend on the solution. (November 15, 2021)

17. To what extent is the system managing documents not related to vendor certification (i.e. procurement docs, communication templates)?

The documents captured are those documenting MWBE and SDVOB directory searches as well as good faith efforts documentation. (November 15, 2021)

18. Is there an existing document repository platform that would remain and require integration with a new offeror?

19. Is there an anticipated percentage of the total estimated budget that would be applied to licensing versus development?

The solution must perform a quantitative analysis of the potential for NYS certified MWBE and SDVOB firms to participate on a particular agency contract. (November 17, 2021)

30. Please elaborate on what type of reports you are looking for. What do these reports look like?

These reports include the quantitative and qualitative analysis of qualified MWBEs and SDVOBs available to participate in our agency contracts. The appearance of these reports may vary in appearance based on the solution. (November 17, 2021)

31. What data are they pulling from? Is that captured in the list of integrations?

32. Are these reports already created and we're going to leverage them (i.e. they're in an external system and we're pulling them)? Or do they all need to be created from scratch?

We are anticipating that the reports will be built-in within the system or the solution would have the capability of creating the reports. (November 15, 2021)

33. Are we going to be sending the report via PDF somewhere? Or will this be more of a dashboard?

The report should be able to be saved in different formats such as PDF, Excel and/or Word. (November 15, 2021)

34. Overall, how many reports are we talking about? And, if there are more than 1, will they be in a similar format to each other?

We are seeking more than one report and they should be similar in format to each other; however, we would consider one report if we had the ability to filter the information in the report. (November 15, 2021)

35. Is Requirement 5 a following up to Requirement 2? (i.e. they will search for the MWBEs/SDVOBs through the data grid produced in requirement 2, and then be able to click on which ones they to reach out to via batch email)? If not, please explain in further detail what you are looking for.

Yes, that would be preferable. (November 15, 2021)

36. Please elaborate on what you mean by a "Document Management Platform." Is this just a repository of documents? Will there be a versioning aspect to this (i.e. the ability to save multiple versions of the same document)?

This is just a repository of documents that is built-in within the solution. (November 15, 2021)

37. What documents will be uploaded? What format will they be in (.PDF, .doc, etc.)?

38. Who will be uploading the documents? Why will they be uploaded them? Please explain the logic at a high level.

Agency staff will be uploading the documents. (November 15, 2021)

39. Who will be accessing the documents? Why will they be accessing them? Will there be any processes that revolve around accessing these documents (e.g. an will open the document and perform some data entry while referencing the document). Or, are these documents just being uploaded for future reference or auditing purposes?

Access is limited to Agency staff. (November 15, 2021)

40. Do you have any estimates as to the number of documents?

Up to 5,000 documents. (November 15, 2021)

41. Do you have any estimates as to the size of documents?

We do not have an estimate. The documents are typically 1 to 25 pages. (November 15, 2021)

42. Will these documents be saved on the OutSystems platform, itself? Or will they need to be stored in an external database (or pushed to one of the integration points listed above)?

The documents should be stored within the solution. (November 15, 2021)

43. Referring to performing outreach services, is this a separate/different from the batch email requirement listed in Requirement #5? If so, how do I identify which MWBEs/SDVOBs I want to reach out to (i.e. will there be some sort of search/filtering capability so I can figure out who I want to reach out to)?

44. Where will the data regarding upcoming procurement opportunities be coming from? Is this from the NIGP integration?

The data will be coming from the Agency. (November 15, 2021)

45. Will there need to be a calendar for the upcoming procurement opportunities? Or simply a data grid/table?
