Please take notice that New York State Homes and Community Renewal (HCR) will conduct a public hearing for the purpose of receiving comments on the draft State Plan for the Sustainable Energy Resources for Consumers (SERC) award for the Weatherization Assistance Program for Program Year 2022.

The SERC award and the Weatherization Assistance Program are funded by the U.S. Department of Energy. The program is administered in New York State by HCR. The purpose of the program is to increase the energy efficiency of dwellings owned or occupied by low-income persons, expand the green workforce, and reduce carbon emissions while improving health and safety, especially for low-income persons who are particularly vulnerable such as the elderly, handicapped and children.

The public hearing is being held pursuant to Title 10, Code of Federal Regulations, Section 440.14(a). Interested parties are invited to provide testimony regarding the SERC award by appearing at one of the public hearing locations or via WebEx. If you would like to make a presentation during the meeting, you must provide written testimony at the time of your presentation.
