JUNE 2023

Renewal Application and Annual Performance Report (APR) Available

- June 16, 2023—Contract Extension Request Deadline (if needed).

JULY 3, 2023

First Disbursement Available

- If the renewal application is approved, the first disbursement will be available no earlier than **July 3, 2023**, and upon the successful execution of a Grant Agreement and approval of the Annual Performance Report.

AUGUST 11, 2023

Application and Annual Performance Report Due

- Application and all related documents must be uploaded via CDOL.
- 2022-23 APR must be uploaded via CDOL.
- No extensions will be granted.

DECEMBER 2023

Mid-Year Report Released / Deadline to Execute

- Mid-Year Reports will be reviewed in the order they are received. If approved, all Grant Agreements **MUST** be executed by **December 29, 2023**.
- Failure to execute a grant agreement by 12/29 will result in a reduced award.**

JANUARY 1, 2024

Final Disbursement Available

- The final disbursement will be available no earlier than January 1, 2024. The final payment is contingent upon the submission and approval of the Mid-Year Report and the company's most recent audit.

FEBRUARY 16, 2024

Mid-Year Report, Final Disbursement, and Audit Due

- All documents must be uploaded via CDOL

MARCH 29, 2024
