Please take notice that New York State Homes and Community Renewal (HCR) will conduct a public hearing for the purpose of receiving comments on the draft Weatherization Assistance Program State Plan for the 2024 Program Year.

The Weatherization Assistance Program is funded by the U.S. Departments of Energy and Health and Human Services. The program is administered in New York State by HCR. The purpose of the program is to increase the energy efficiency of dwellings owned or occupied by low-income persons, reduce their total residential energy costs, and improve their health and safety, especially low-income persons who are particularly vulnerable such as the elderly, handicapped and children.

The public hearing is being held pursuant to Title 10, Code of Federal Regulations, Section 440.14(a). Interested parties are invited to provide testimony regarding the Weatherization Assistance Program by appearing at one of the public hearing locations. If you would like to make a presentation during the meeting, you must provide written testimony at the time of your presentation.
